2. **The next release will be made on fulfillment of the following conditions:-**

- (i) Setting up of SPMU in the State
- (ii) Setting up of DPMU/CDMU in the State
- (iii) The funds should be utilized as laid down in the framework of implementation of the SPMRM.
- (iv) Preparation of Detailed Project Reports for the components identified under the CGF
- (v) Commencement of basic activities on site- achievement of works expenditure to the extent of 60% of the CGF released.
- (vi) The release of funds is subject to audit by Internal Audit of Department of Rural Development.
- (vii) Funds should not be diverted for any purpose other than as mentioned at (i) & (ii) above.

3. The accounts of the grantee institutions will be audited by the Comptroller and Auditor General of India and the Internal Audit of the Principal Accounts Office of the Ministry of Rural Development under Chief Controller of Accounts, in terms of Rule 211 (i) and 211 (2) of the General Financial Rules.

4. This is the first installment. Hence, no Utilization Certificate (UC) is pending.
