*Respected Sir,*

As you are aware, Shyama Prasad Mukherji Rurban Mission (SPMRM) targets developing 300 clusters across the country in a time bound period of three years for each cluster. To achieve the target of the Mission in the stipulated time period, progress on various provisions of the SPMRM framework, is expected in the State. We request you to share information on the following points for your State:

1. **Notification of clusters as planning areas** under the relevant State Town and Country Planning Acts/ PRI Acts/ other Planning acts, is one of the conditions in the development of Rurban cluster.

During submission of phase 1, 2 and 3 clusters, it was informed that the clusters have been approved by the Chief Secretary, Government of Andhra Pradesh for developing them as a planning area under the Andhra Pradesh the Panchayati Raj Act. However, the copy of the notification for each cluster as planning area under the relevant act in the State has not been received so far. Copies of notification may please be shared with us.

Release of 2<sup>nd</sup> and 3<sup>rd</sup> instalment of Critical Gap Funding (CGF), is contingent upon fulfilling the conditions given in Sanction Order for 1<sup>st</sup>/ 2<sup>nd</sup> release of CGF. Therefore, progress made in initiation and preparation of Master plan for each cluster may also be provided.


2. **Setting up Institutional Structure** i.e. State Project Monitoring Unit (SPMU), District Project Monitoring Unit (DPMU), Cluster Development and Management Unit (CDMU) and placing requisite manpower in these units is required as per clause 11.0 of the Framework of Implementation. The conditions of Sanction order also mandate State to place fully functional units to release 2<sup>nd</sup> and 3<sup>rd</sup> instalment of CGF. Progress made on this front is required in the following format from your State.

4. Ministry had earlier written to States (reference M-12015/01/2016-Rurban dated 03<sup>rd</sup> July, 2018) to complete all data entry for cluster formation, ICAP, DPRs and MPR section in **RurbanSoft** by 10<sup>th</sup> July 2018. Status of data entry till date is as per Annexure-1. States are required to complete the pending cluster data entry and Monthly Progress Report (MPR) entry in RurbanSoft within 2 weeks.

It is requested that the required information in (1) and (2) above, be furnished within one week from the date of issuance of this letter.
