With reference to your above referred letter seeking change in the Phase 1 cluster, and submission of 1 Non-tribal cluster under Phase-2 of SPMRM. The proposal has been examined. I am directed to state that:

1. Under Phase-1, Cluster Xeldem under Sub-District: Quepem, District: South Goa was selected by the State, and ICAP has already been approved by MoRD in March 2017 for a total investment of Rs. 100.20 crore including agreed CGF of Rs. 30.00 crore. Change of Cluster under Phase 1 at this stage would lead to delay in implementation of the Mission due to re-preparation of ICAP and requirement of several approvals in the process for the new cluster. You may consider revisiting the decision to change the Phase 1 cluster at this stage.
2. As per the Framework of Implementation for SPMRM, the cluster is chosen from among the top 20 sub-districts in each State identified and communicated by MoRD in line with the approved selection methodology. The proposed sub-district Dharbandora in District South Goa is not listed in the top 20 sub-districts under non-tribal category, which is enclosed for your reference. In case of reorganization of subdivisions in the State after the Census-2011, the comparative list of GPs after reorganization may be submitted.
3. Another proposed sub-district Bardez in District North Goa ranks 3rd among the top 20 sub-districts, and therefore can be considered by the State.
3. You are required to submit the chosen cluster details along-with minutes of the SLEC approval for the clusters.

In continuation to our above referred D.O. and as a final reminder, you are advised to submit the SLEC approved cluster details within 2 weeks.
