Sir,

I am directed to convey the sanction of President of India to the payment of Grants-in-aid amounting to Rs.4,05,00,000 (Rupees Four Crore Five Lakh Only) to the State Government of Arunachal Pradesh as Central Assistance for the following SPMRM clusters under Phase-III.

1. The next release will be made on fulfillment of the following conditions:-

- (i) Approval of DPRs by SLEC for all components and DPR templates by MoRD.
- (ii) Commencement and completion of all soft components for which DPR preparation is not required, such as training modules for all skill development activities, purchase of equipment, procurement of cabling lines etc. -such components would be identified for each cluster in consultation with the Ministry.
- (iii) Progress of work on ground as identified under the CGF and convergence amount (after approval of DPR by SLEC and DPR template by MoRD) as per schedule indicated in the ICAP and DPR. This should be to the extent of 60% of the CGF released.
- (iv) Setting up of the State Project Management Unit-SPMU with adequate number of professionals as per qualification criteria mentioned in Framework of Implementation.
- (v) Setting up of the District Project Management Unit and/or Cluster Development Management Units as decided by the State with each unit manned by adequate number of professionals.
- (vi) Initiation of the Master Planning process for each cluster in consultation with the town planning department of each State.
- (vii) Funds should not be diverted for any purpose other than as mentioned at (i) to (v) above.

- (viii) Furnishing of Utilization Certificate for 60% of the amount released following the heads indicated in (i) to (v) above generated through EAT Module.
- (ix) The corresponding State Share of Rs.0.45 crore is to be released as soon as the Central Share is received in the Rurban -SNA account.
- (x) The release of funds is subject to audit by Internal Audit of Department of Rural Development.

2. The State should submit the expenditure statement of funds released earlier for ICAP preparation generated through EAT Module.

3. The accounts of the grantee institutions will be audited by the Comptroller and Auditor General of India and the Internal Audit of the Principal Accounts Office of the Ministry of Rural Development under Chief Controller of Accounts, in terms of Rule 236 (1) and 236 (2) of the General Financial Rule 2017.

4. The expenditure is debitable to the following Head of Accounts under Demand No. 082 Department of Rural Development (2018-19).
