

I am directed to convey the sanction of President of India to the payment of Grants-in-aid amounting to Rs.1,40,00,000 (Rupees One Crore Forty Lakh Only) to the State Government of Assam as Central Assistance for the following SPMRM clusters under Phase-III.

1. The release is subject to the following conditions:-

- (i) The funds shall be utilized for preparation of Integrated Cluster Action Plan.
- (ii) Apart from (i) above, if the State so desires, these funds may also be utilized for setting up initial institutional arrangements for SPMRM in the State.
- (iii) The funds should be utilized as laid down in the framework of implementation of the SPMRM.
- (iv) The release of funds is subject to audit by Internal Audit of Department of Rural Development.
- (v) Funds should not be diverted for any purpose other than as mentioned at (i) & (ii) above.




